## Kid's Summer Camp Participant Registration and Release Form

**Registration and Refunds:** Registration and payment for the Cheers to Art Summer Camp must be completed and emailed back to [Julie@CheerstoArt.com](mailto:Julie@CheerstoArt.com) no later than 7 days prior to desired camp start date. Full payment is required at the time of registration to reserve the child's space. Due to limited space, refunds will not be given. Participants may sign up for any or all the weekly camps. There will be no proration of fees for any days a child participant cannot attend.

**Age Guidelines:** Cheers to Art Summer Camp is recommended for children ages 6 to 12 years old. However, the week of June 10<sup>th</sup>-June 14<sup>th</sup>, 2019 is for ages 12-17 ONLY, no exceptions.

**Hours of Operation:** Camp is from 9:00am-3:00pm.

**Behavior:** If your camper's behavior is disruptive or disrespectful to other campers or instructors, your child will be asked to not return, and payment will not be refunded.

**Pick-up and Drop-Off Procedures:** Children need to arrive between 9:00-9:15 am and must be picked up by 3:00pm. Parent/guardian must park their vehicle and walk their child into the Camp and sign the child into the Camp.

**Late Pick-Up Policy:** There will be a late-fee assessed for children who are picked up after 3:05 pm. The late fee is \$1.00 for each minute past 3:05 pm. Repeated late pick-ups may result in the removal of the participant from the program, with no refund for prepaid programs.

**Medical Needs/Allergies:** We are **NUT FREE**, please do not pack your child anything that contains ANY type of nuts. Cheers to Art staff are not permitted to administer medication to program participants. In the event of a medical emergency, Cheers to Art staff will call 911. Parents will be contacted in case of emergency by calling the cell phone number provided.

**Dress Code:** Children should dress appropriately for getting messy! Cheers to Art will provide aprons but acrylic paint is not clothing friendly.

**Personal Belongings/Food:** Please put the child's name on all articles of clothing, snack bags, bags, etc. **Children should not bring toys or electronic devices.** They will be very busy. Children will be responsible for their belongings. Camper must bring in their own nonperishable lunch, morning snack and drink. An afternoon snack will be provided.

**Waivers and Informed Consent:** *By signing this form, I, as parent/guardian, permit Cheers to Art to use pictures of my child(ren) as a program participant in promotional literature, videos, and the Cheers to Art website. I understand my child(ren)'s name(s) will not be published.*
